She has thirty publications, five edited books, three conference proceedings, and two edited special issues in journals.

Martin J. Ball is Honorary Professor of Linguistics at Bangor University, Wales, having previously held positions in Wales, Ireland, the US, and Sweden. He holds a PhD from the University of Wales, and a DLitt from Bangor University. He co-edits the journals *Clinical Linguistics and Phonetics* and *Journal of Multilingual and Bilingual Speech*, as well as book series for Multilingual Matters and Equinox Publishers.
