Fig. 6.1 The great horned owl has females that are larger than males. Its “horns” are not ears or horns, but tufts of feathers. It is believed to occur from Nova Scotia to east Texas and to Minnesota and southward to South America. Great horned owls breed early in late January or early February 44

Fig. 6.2 The wood stork, or sometimes called the wood ibis, is the only stork that breeds in North America. It extends its range throughout South America, in tropical and subtropical regions..... 46

Fig. 7.1 The monarch is perhaps the best known of the butterflies in North America; it is often called the milkweed butterfly. Besides occurring in North America, monarchs are found in Europe and New Zealand. It is famous for its migration in the Americas, especially to Mexico, which may span 3–4 generations 56
