She received her Ph.D. in organizational behavior from the Graduate School of Management at the University of California, Irvine, and her bachelor's degree in psychology from Scripps College. Gibson's research interests include communication, interaction and effectiveness in teams, the impact of culture and gender on work behavior, social cognition, and international knowledge management. She is coauthor with P. Christopher Earley of *Multinational Teams: A New Perspective*. Her research has appeared in many scholarly journals, including *Administrative Science Quarterly*, *Academy of Management Journal*, and *Academy of Management Review*. She is the recipient of numerous awards recognizing her research, including grants from the Thomas J. Watson Foundation, the Carnegie Bosch Institute for Applied International Management, the Center for Innovation and Management Studies, and the National Science Foundation.

Susan G. Cohen is a senior research scientist at the Center for Effective Organizations, Marshall School of Business, University of Southern California.
